- **A non-refundable commitment fee of \$50 per child due is due at registration. Families with children in K-8 at Corpus Christi are only required to pay the \$300 family commitment fee at time of registration.**
- Financial commitment for a school year *begins in July and ends in June of the following year.*
- Tuition is pro-rated daily for enrolling or withdrawing your child after the school year begins.

This financial agreement form is part of the required registration material which must be returned with all other forms and fees. The registration of your child(ren) will not be considered complete until this form has been submitted.

We agree as a condition of the school to pay the tuition and fees as reflected on this form. We understand that these fees are due for our children to remain in the school. If payment is not received by the agreed upon day of the month, we understand that a late charge of \$15 will be added to each month when payment is in arrears. We understand that a service charge of \$40 may apply to all checks returned by the bank. We understand that if tuition and other incidental expenses are delinquent more than 60 days, and an acceptable alternative arrangement has not been approved by the pastor, then our child(ren) will not be permitted to return to school until all delinquent obligations are paid in full. We understand that the school shall have the right to legal action for nonpayment of tuition and fees, and we will be responsible for all cost of collection, including court expenses and reasonable attorney’s fees. In addition, the school has the right to withhold access to skyward, report cards, and transfer of records for a student if tuition and fees are outstanding more than 60 days.
