

## 2019-2020 FINANCIAL AGREEMENT FORM (Grades K-8)

The cost of educating one child for one year at our school is in excess of \$7,600. This cost is only partially paid through tuition. The balance of the cost of educating students is paid by the parishes of Holy Trinity, Historic St. Patrick's, St. Mary's of Downs, St. Patrick Church of Merna, and St. Patrick of Wapella. Parishioners with children enrolled in our school are expected to attend Mass weekly, participate in the life of the parish to the best of their ability. Part of parish participation is financial support.

We understand that the Commitment Fee of \$300 per family is due upon registration, and a child must be registered to be awarded assistance.

- Financial commitment for a school year begins in July and ends in June of the following year.
- Tuition is pro-rated daily for enrolling or withdrawing your child after the school year begins, as stated in our handbook.
- All families are required to enroll in FACTS for payment of the school tuition. There is an enrollment fee of \$45 for each family. This \$45 fee is waived if the family chooses to pay tuition in full before the first day of school. More information on reverse side.
